## PRIVACY NOTICE

### RESPONSIBLE FOR THE TREATMENT:

**MAGNOS AGAVEROS DEL CAMPO, S.P.R. DE R.L.**, hereinafter **MAGNOCAMPO**, with address at Calle Rafael Sánchez 200, Colonia Don Bosco, with zip code 45380, in Amatitán, Jalisco, informs you that it is responsible for ensuring compliance with the principles of protection of personal data, established by the Federal Law on Protection of Personal Data Held by Private Parties.

### THE PURPOSES OF DATA PROCESSING:

**MAGNOCAMPO**, in compliance with the principles of proportionality and minimization, only collects and makes legitimate use of adequate, necessary and relevant personal data for the fulfillment of the object of the supply contract that has been concluded with you, as well as to comply with the purposes of the treatment informed in this Privacy Notice.

For no reason **MAGNOCAMPO** will process personal data for purposes other than those that are not compatible with those reported in this Privacy Notice or obtain data that does not meet the criteria indicated above.

### OPTIONS AND MEANS THAT MAGNOCAMPO OFFERS TO LIMIT THE USE OR DISCLOSURE OF DATA:

**MAGNOCAMPO**, is not obliged to provide partial or proportional information to third parties, unless an authority in full exercise of its functions, requires them with the protocol of law, even so **MAGNOCAMPO**, offers that you may limit the use or disclosure of your personal data, obtained to sign the supply contract, as well as all information is written or by electronic means that is provided in order to comply with the object of said contract, sending a request to the Legal Department of **MAGNOCAMPO**, to the email [eflores@gruposolave.com](mailto:eflores@gruposolave.com), adding to this the requirements to prove your identity, as well as the procedure to meet your request will be governed by the same criteria indicated in the section of means to exercise the rights of access, rectification, cancellation or opposition, in accordance with the Federal Law on Protection of Personal Data Held by Private Parties.

In the event that your request is appropriate, the Legal Department of **MAGNOCAMPO** will register you in **MAGNOCAMPO**'s own exclusion list, in order for you to comply with an information confidentiality contract.

### MEANS TO EXERCISE THE RIGHTS OF ACCESS, RECTIFICATION, CANCELLATION OR OPPOSITION

You have the right to know what personal data we have about you, what we use them for, the conditions of use we give them and to obtain a copy of these in a readable and easy-to-read format (Access). Likewise, it is your right to request the correction of your personal information in case it is outdated, inaccurate or incomplete

(Rectification); that we remove it from our databases when appropriate (Cancellation); as well as to oppose the use of your personal data for specific purposes (Opposition). These rights are known as ARCO Rights. These rights may be exercised with respect to the partiality or totality of the personal data subject to treatment informed in this Privacy Notice.

For the exercise of any of the ARCO Rights, as well as to revoke your consent for the processing of your personal data, you must send an email to the Legal Department of **MAGNOCAMPO** to the [eflores@gruposolave.com](mailto:eflores@gruposolave.com) email, where you will be attended in a timely manner.

Your request must be made in writing, specifying the Exercise of ARCO Rights, Revocation of Consent and / or Limitation of Use or Disclosure of Personal Data, clearly exposing all the elements to be able to meet your request in accordance with the applicable regulations. In order for the Legal Department of **MAGNOCAMPO** to follow up on your request, you or your legal representative must correctly prove your identity for which it is necessary to attach, power of attorney with which you prove your personality, as well as a copy of any current legal identification.

In the event that the information provided in the mail is erroneous or insufficient, or the corresponding accreditation documents are not accompanied, the Legal Department of **MAGNOCAMPO**, within five (5) business days following receipt of the request, may require you to provide the elements or documents necessary to process it. You will have ten (10) business days to respond to the request, counted from the day after you receive it. If no response is given within that period, the corresponding application will be considered not submitted.

The Legal Department of **MAGNOCAMPO**, will communicate the determination adopted, within a maximum period of twenty (20) business days from the date on which the request was received, so that, if appropriate, it makes it effective within fifteen (15) business days following the communication of the response. The response will be given electronically to the email address that sent the information.

#### **DATA TRANSFERS**

##### **Not subject to consent**

**MAGNOCAMPO** may transfer your personal data only to national entities, without requiring your consent for the following purposes:

- Competent authorities and third parties in the cases provided for by law.
- To the Public Registry of Commerce (RPC) to verify the quality of the data contained in its Articles of Incorporation.

##### **It is necessary to obtain your consent.**

To any other entity, whether national or foreign that is not in the previous case, always **MAGNOCAMPO**, **will inform you if it is the case that any entity or third party is requesting your information, as long as it does not fall into the above requirements.**
